ORDINANCE #2008-08

AN ORDINANCE OF THE CITY OF SEASIDE, OREGON, AMENDING ORDINANCE 2008-06 REGARDING ADOPTING A SYSTEM DEVELOPMENT CHARGE METHODOLOGY FOR PARKS AND RECREATION AND WASTEWATER

Mark Winstanley, City Manager, stated at a previous Council meeting Council adopted the new Systems Development Methodology charges but the final report had not been received as of the date of the changes. Staff was asking Council to adopt the new System Development Charges Methodology based on the final report dated October 2008. Mr. Winstanley further stated in addition there had been one change with the commercial structures because System Development Methodology was based on the number of water meters and there were times when more then one water meter was needed. Commercial properties often need more then one water meter because one meter was used just for the fire flow for the sprinkler system in the buildings. The building department often requested the builder have a second meter for the fire flow system which gives the building official the ability to waive the System Development charges for the other water meter.
